## IHP Council Resolution XXVI-4 - 2024 (extrait)

Initiating the Process of the Establishment of a Megacities Alliance on Water and Climate Change (MAWAC) as a UNESCO Cooperation Platform

- Development of a proposal for the establishment of the Megacities Alliance on Water and Climate Change (MAWAC).
- Nomination of a new Working Group to develop a proposal (framework) for the establishment of MAWAC:
  - will elaborate and further develop the existing draft proposal, as it considers appropriate and required in the framework of the IHP Council Resolution XXVI-4 implementation
  - exclusively within the mandate given by the IHP Council Resolution XXVI-4
  - in line with the UNESCO's overall mandate and objectives
  - in line with UNESCO rules and regulations, including Financial Regulations and Rules
  - with clear contributions of MAWAC to IHP-IX Strategic Plan
- Two stakeholders' meetings





# Membership: cities' commitments




Cities applying to join the MAWAC as full members must commit and demonstrate their willingness and commitment to:

- engage in achieving MAWAC's mission and objectives towards becoming a water-secure and resilient city, striving to provide access to water and sanitation services, meeting quality, quantity and affordability requirements, to its inhabitants;
- commit with MAWAC thematic and focus areas as formulated above.
- contribute to MAWAC's mission, objectives and actions by actively participating in MAWAC activities at the global and regional levels;
- cooperate with MAWAC member cities in the framework of MAWAC through the sharing of knowledge, innovation, experience, best practices and policies on water and climate change;
- support and help other MAWAC member cities in their efforts towards achieving the MAWAC's vision;
- contribute to observer cities in adopting successful policies and innovations developed by MAWAC members;
- share the values and objectives guiding UNESCO in pursuit of dialogue and international scientific cooperation in the framework of its Intergovernmental Hydrological Programme (IHP).


MAWAC Governance Model Global Scale




Assembly of Mayors of the Megacities - Global Level

- Representatives of
  - Municipalities
  - Academy
  - Water Utilities
- Other potential members
  - River basin authorities
  - Scientific and technical associations
- Nomination by calls
- The number of positions for each sector must ensure the equilibrium of representativeness
- One or two members may be nominated due to recognised expertise
- Number of members: a function of the number of megacities (regional, global)
- The terms of office is four years, renewable for an additional period
- Frequency of meetings: monthly (local, regional); bimonthly (global)

#### ROLES AND RESPONSIBILITIES



- Conceive and lead the development of research projects, studies and innovative programmes
- Contribute to the formulation of water and adaptation policies and strategic plans and programmes
- Oversee and evaluate water policies and programmes
- Look for alternative funding for MAWAC's research and innovation activities
- Contribute to capacity building and scaling up initiatives in collaboration with the Scaling Up Committees
- Lead the organisation of conferences, workshops
- Promote and ensure connection and collaboration of Megacities at the three MAWAC levels
